I. AGENDA ITEM 2.1: ZAP1007BL11 – Gila Farm Land, LLC (Representative: Rupal Patel) – County Case No.: Conditional Use Permit 3670, City Case No.: To Be Determined - A proposal to construct a 485 megawatt solar photovoltaic electric generating facility and associated facilities on 3,645 acres, including three electrical substations, two operations and maintenance buildings, inverters, transformers, 34.5 kV distribution lines, and associated switchgear located on either side of Interstate-10, generally located westerly of Neighbors Boulevard, northerly of 20th Avenue, and southerly of 10th Avenue within the land use jurisdictions of the County of Riverside and City of Blythe (Compatibility Zones B1, C, D, and E of the Blythe Municipal Airport Influence Area). Continued from October 13, 2011.

II. MAJOR ISSUES

- Proposed distribution and transmission lines extend through Compatibility Zones C and D;
- 2. Reflectivity/glare; and
- 3. Cumulative impacts of multiple energy projects.

III. STAFF RECOMMENDATION

Staff recommends that the Commission consider the staff and applicant presentations and any public testimony at its December 8, 2011 public hearing, and subsequently <u>CONTINUE</u> this matter to its January 12, 2012 hearing calendar, pending submittal of Form 7460-1 to (and acceptance for processing by) the FAA for all required structures. In the event that the applicant is able to document such acceptance prior to the hearing, staff would recommend a finding of <u>CONDITIONAL CONSISTENCY</u> for the project, subject to receiving a Determination of No Hazard to Air Navigation from the FAA and the conditions specified herein, plus such additional conditions as may be required pursuant to FAA requirements.

IV. PROJECT DESCRIPTION

The project proposes to construct a 485 megawatt solar photovoltaic electric generating facility and associated facilities on 3,645 acres, including three electrical substations, two operations and maintenance buildings, inverters, transformers, 34.5 kV distribution lines, 230 kV transmission lines, and associated switchgear.

I. **AGENDA ITEM 3.1:** ZAPEA02FV10 – ALUC Initiative – The Riverside County Airport Land Use Commission will consider whether to adopt a Negative Declaration, prepared pursuant to the California Environmental Quality Act, for the proposed 2011 Amendment to the 2007 French Valley Airport Land Use Compatibility Plan ("2007 FVALUCP") and whether to adopt the 2011 Amendment.

The 2011 Amendment would revise the boundaries of Airport Land Use Compatibility Zones (A, B1, B2, C, D, and E) identified in the previously adopted 2007 FVALUCP to reflect the removal and deletion of the previously planned (but never built) secondary runway from the French Valley Airport Master Plan. As the 2011 Amendment proposes to reconfigure the Compatibility Zones, the proposed amendment would modify the applicability of the previously adopted 2007 FVALUCP to various properties within the French Valley Airport Influence Area ("AIA"). The proposed amendment, however, would not change the development restrictions or criteria established for each Compatibility Zone by the 2007 FVALUCP. The 2011 Amendment also would revise projected noise level contour maps around the Airport and make changes to informational tables in the 2007 FVALUCP to reflect adoption of the French Valley Airport Master Plan and changes to airport features and activity since 2002. French Valley Airport is located easterly of Winchester Road and southerly of Auld Road. The AIA includes properties in the cities of Murrieta and Temecula, and unincorporated Riverside County.

II. MAJOR ISSUES

None have been raised to date. The Native American Heritage Commission has requested consultation with Tribal representatives. This staff report includes a response to this comment on the Initial Study/Negative Declaration.

III. STAFF RECOMMENDATION

Staff recommends that, after the close of public hearing, the Commission:

- (1) Approve the Negative Declaration for the 2011 Amendment to the 2007 French Valley Airport Land Use Compatibility Plan ("2007 FVALUCP"), and thereby find that:
 - a. having considered the Initial Study/Negative Declaration document, the comments received during the public review process, and the record before the Commission, there is no substantial evidence that adoption of the 2011 Amendment to the 2007 FVALUCP will have a significant effect on the environment; and
 - b. the Negative Declaration reflects the Commission's independent judgment and analysis;
- (2) Adopt the 2011 Amendment to the 2007 FVALUCP; and
- (3) Direct staff to return to the Commission on January 12, 2012, with the appropriate resolution memorializing the Commission's final action taken at the December 8, 2011 public hearing.

IV. PROJECT DESCRIPTION

The 2011 Amendment also would revise projected noise leve contour maps around the Airport and make changes to informational tables in the 2007 FVALUCP to reflect adoption of the French Valley Airport Master Plan and changes to airport features and activity since 2002. The 2011 Amendment would not change the development restrictions or criteria established for each Compatibility Zone by the 2007 FVALUCP.
