The finding of Conditional Consistency for ZAP1060MA09 (PP09-02) shall take effect only when the proposed Specific Plan Amendment, to the Meridian Specific Plan, is found consistent by the Riverside County Airport Land Use Commission. The Specific Plan Amendment shall amend the limitation of quantity for above ground storage of nonaviation flammable material to allow 10,000 gallon tanks as proposed in case ZAP1060MA09.

ZAP1060MA09 – Sysco Corporation (Representative: Scott Barker, Kimley-Horn and Associates, Inc.) – Jurisdiction Case No.: PP09-02 (Plot Plan; March JPA Case). A proposal to construct and operate a 515,000 square foot food storage and distribution facility on a 45-acre site located northerly of Van Buren Boulevard, westerly of Interstate 215, and easterly of Meridian Parkway, within the Meridian Specific Plan and the land use jurisdiction of the March Joint Powers Authority. Robert Eppers, spokesman for the French Valley concerned citizens came forward and expressed his interest in becoming an associate ALUC Commissioner. He is a pilot and a citizen of the French Valley area. He also expressed opposition to the French Valley Energy Power Plant proposal. Ed Cooper, ALUC Director informed the Commission that we submitted a letter to the Riverside County Planning Department during the comment period on the Notice of Preparation for the EIR regarding the French Valley Energy Power Plant. Troy Childs, French Valley Concerned Citizen requested a letter of Vacate or Abandonment for case ZAP1027FV08 expressing what took place on August 13, 2009. BT Miller, County Counsel advised that there is enough information at this time indicating the Commissioners had already taken action at the August 13th meeting. Ken Fickett, French Valley Energy Project Proponent came forward to answer any questions and prepared presentation charts to the Commission in support of the French Valley Energy Center.

7.0 COMMISSIONER'S COMMENTS

Commissioner Glen Holmes requested Ed Cooper, ALUC Director enlighten the Commission on the new proposal plan for Hemet Ryan Airport and their gliders. Ed Cooper had nothing concrete to mention publicly about Hemet Ryan Airport, as far as the plan they are still finalizing the exact detail of what EDA and the Federal Government will fund. As for the gliders, Mr. Cooper knows only of the information provided in the newspaper, stating they have been asked to remove that operation from the airport and understands they are looking for a new home somewhere in the County.
